Re: **Democrats Abuse Power in IRS to Entrench Partisanship**

The Internal Revenue Service (IRS), an agency that should operate without any partisan bias appears to be operating under near complete Democratic Control.

A look into the IRS Commissioner's and Deputy Commissioner's office has revealed that Republicans appear to be completely absent within the agency.

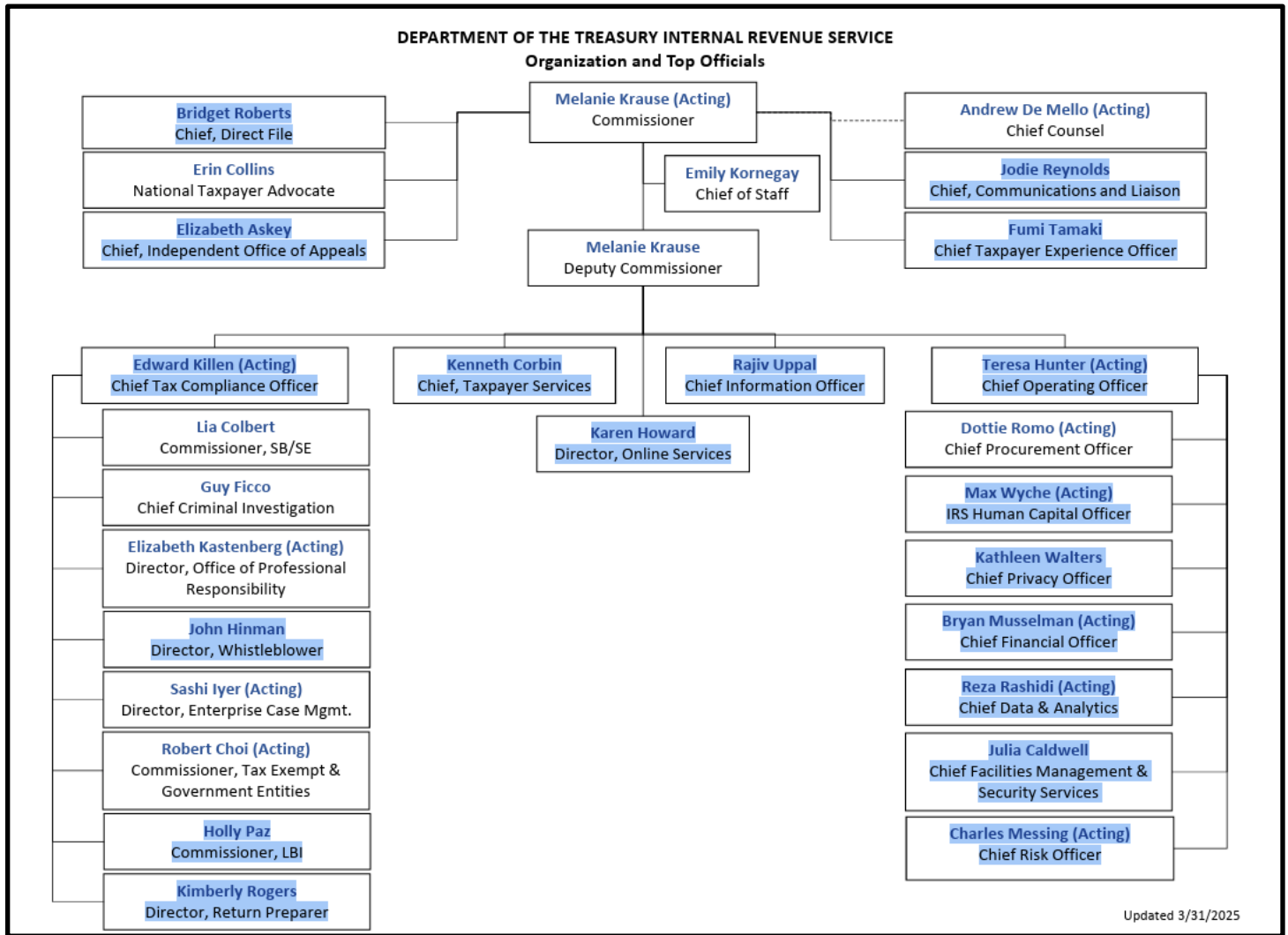
An analysis of all twenty-nine current IRS officials in each office has revealed that over 60% of the officials outwardly support the Democratic party or liberal initiatives. No Republicans were found via social media, voter registration, or campaign finance records.

Highlights from the report include:

- Over 60% of IRS leadership have outwardly supported Democratic politicians or liberal policies.
- No officials in IRS leadership have supported Republican initiatives or candidates
- Numerous officials have openly opposed President Trump through campaign donations
- The agency is currently being led by several officials that have openly advocated for Diversity, Equity, and Inclusion (DEI) policies

**IRS Leadership Chart Shows Extreme Bias**

Records show that at least eighteen of twenty-nine people in the IRS commissioner’s and deputy commissioner’s office are registered Democrats or have supported liberal initiatives. No IRS officials in either of these offices outwardly supported any Republican positions, officials, or groups.

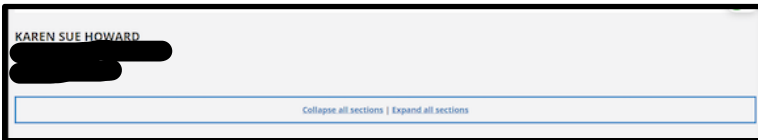

**Targeting Conservative Organizations**

Holly Paz was accused of targeting conservatives in 2013.

*Senior Internal Revenue Service official Holly Paz, who helped oversee the agency's internal review of how it scrutinized conservative groups' applications for tax-exempt status, hasn't been formally accused of any wrongdoing. But she has been on administrative leave since early June, and has been subject to harassment after coming under fire from congressional Republicans, according to her lawyer, Roel Campos.<sup>22</sup>*
