Re: IRS Office Led by Lois Lerner Disciple is filled with Trump Critics and Democrats

The Large Business and International Division (LB&I) is one of the largest and most powerful departments of the IRS and it's currently being led by Democrats and fierce critics of President Trump.

Led by Holly Paz - a partisan Democrat who allegedly targeted conservatives under the Obama Administration – LB&I is made up of Trump Administration opponents who have promoted content referring to the president as “treasonous” and “deranged.”

Out of forty leadership positions within LB&I, just two Republicans were found within the department.

The tilt towards Democrats, liberals, and Trump critics is currently at an unsustainable level and leaves open the possibility that management could bring about another scandal that targets supporters of the president and conservatives.

Highlights from our findings:

- LB&I is currently being led by Holly Paz. Paz was placed on administrative leave after allegedly targeting conservative organizations during the Obama Administration
- Multiple employees in leadership positions have reposted content disparaging President Trump as “treasonous” and “deranged.” One IRS leader liked a post that likened President Trump to a fascist
- Numerous IRS Officials are Kamala Harris donors and have contributed to causes like Stop Republicans
- Multiple officials support Diversity, Equity, and Inclusion (DEI) initiatives
- Our research could only find two Republicans and they were both found via voter registration. No right-wing social media content could be found from any IRS official at LB&I

Targeting Conservative Organizations

Holly Paz was accused of targeting conservatives in 2013 and was placed on administrative leave.¹

Senior Internal Revenue Service official Holly Paz, who helped oversee the agency's internal review of how it scrutinized conservative groups' applications for tax-exempt status, hasn't been formally accused of any wrongdoing. But she has been on administrative leave since early June, and has been subject to harassment after coming under fire from congressional Republicans, according to her lawyer, Roel Campos.

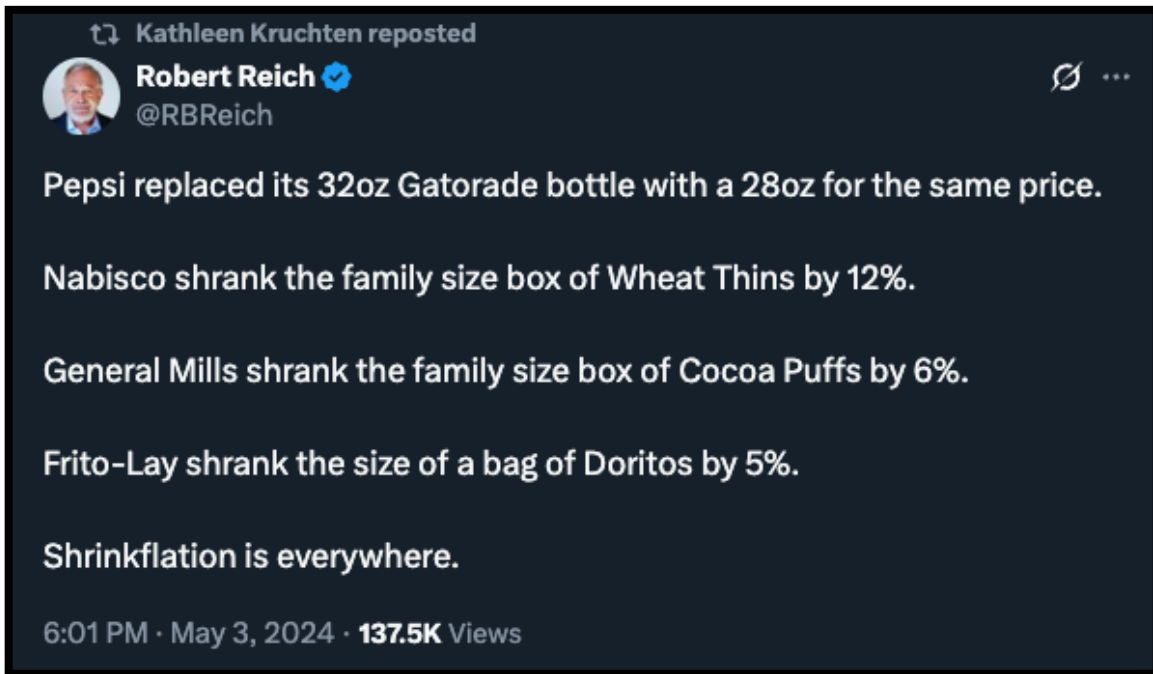

Citizens Climate Lobby Wants a Carbon Tax

Citizens Climate Lobby wants to add a fee to carbon products in the United States.²⁶

A carbon tax becomes affordable for ordinary Americans when the money collected from fossil fuel companies is given as a dividend, or "carbon cash back" payment, to every American to spend with no restrictions. This protects low-and-middle-income Americans who otherwise might not be able to afford the transition.

Studies show that the monthly carbon cash back payments are enough to essentially cover increased costs of 85% of American households, including 95% of the least wealthy 60% of Americans.

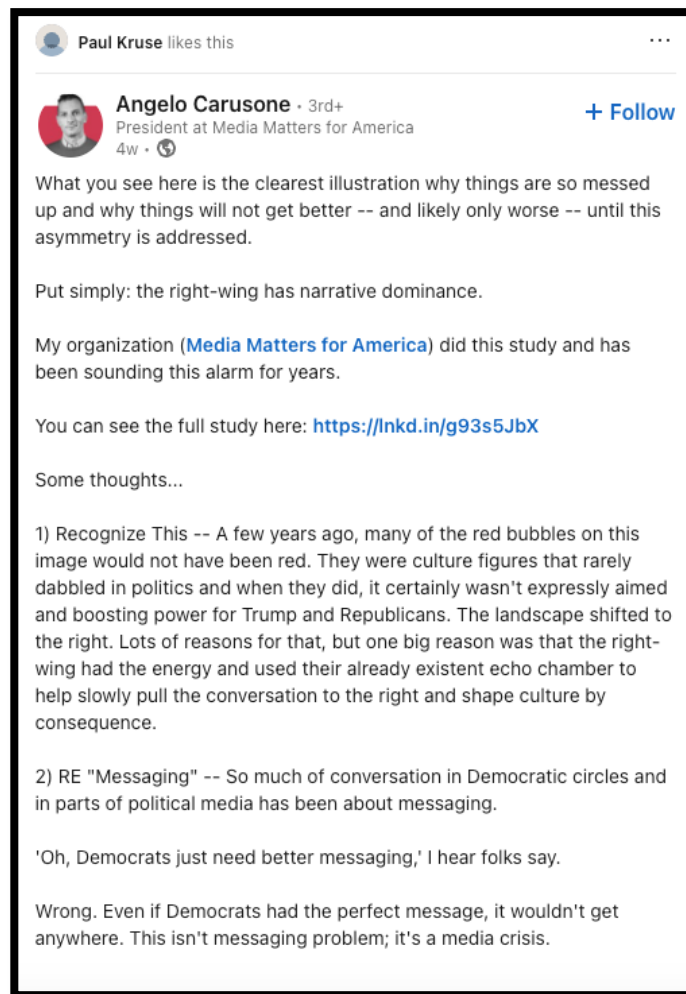


This type of carbon tax is called a “carbon fee and dividend”. Citizens’ Climate Lobby has been advocating for this policy for over a decade.

3) RE "Joe Rogan of the left" -- Some also think it means Democrats need a "Joe Rogan of the left."

But, this misses the mark too. The information landscape is highly fragmented. A single giant player alone won't fix the issue.

What is needed is actually simple: more blue bubbles across many audience segments.

4) RE Resources -- I want to emphasize this is not a resource problem.

Democrats spent billions last cycle on ads. Paid ads have little and diminishing value, especially in such a saturated landscape.

If they spent \$100M of that on storytellers instead, election outcome would have been the same probably. But landscape would look different right now.

Indeed, there is a lot of talk right now about influencers in political circles. But, be careful here and don't be fooled. Much of this talk amounts to simply porting traditional paid media approach to influencer space by way of "pay to post content." This approach not only won't work, but will make problem worse.

5) Fascism is theater -- When Trump first came to power, Fox News and talk radio were the foundations. No doubt. But, over the years, Trump organized power on what used to be considered the fringes. His vehicle for doing that was a massive right-wing media ecosystem -- that yes included Fox and talk radio, but also included this massive online right-wing echo chamber.

There's a reason why so many Trump admin officials are right-wing media fever swamp creatures.

Politics is downstream from culture. The fight for the hearts and minds as well as the future of our society is in the information landscape.

Fascism is theater. And right now, Trump has quite a stage.
